On 11/6/63, PCI [redacted] was interviewed by SAS CHARLES G. DONNELLY and PAUL G. DURKIN. He came to NYC with DOROTHY MC GUIRE on 11/5/63 and they are going to Ohio on 11/7/63 for a few days before returning to New York.

[redacted] advised that VICTOR COLLINS is no longer working for the MC GUIRE sisters and is in Calgary, Canada working for PCI. (Former NYO PCI VICTOR COLLINS is the individual that had a fight with GIANCANA in Lake Tahoe, which led to the ruling by the Nevada Gaming Commission that FRANK SINATRA must give up his holdings in casinos in Las Vegas. The first information concerning this was furnished by PCI [redacted] He said COLLINS has suffered no repercussions because of this fight.

[redacted] stated the MC GUIRE sisters are going to continue and explained that DOROTHY and CHRIS had told PHYLLIS she must sever her connections with GIANCANA if she wishes them to continue. This was prior to their appearance on the JIMMY DEAN show the first week of October, 1963.

PHYLLIS agreed to this and DOROTHY and CHRIS came to NYC the weekend preceding the show. That Saturday night, the sisters went to La Scala Restaurant, NYC and PHYLLIS received a phone call from GIANCANA there. DOROTHY became angry and left NYC returning to Calgary. The following day, PHYLLIS called DOROTHY and said it was all over between SAM and her and she will not see him anymore. However, she said she will continue to talk to him occasionally on the phone. PHYLLIS was crying and DOROTHY agreed to return as long as PHYLLIS will not see GIANCANA again. ✓

\_\_\_\_\_ advised the sisters are to appear at Blimstroms (ph) in Boston, 11/25/63 and return to NYC for the JIMMY DEAN show, 11/28/63. ✓

He said that he has not seen subject recently and as far as he knows, PHYLLIS is living up to her bargain. ✓

BEN SWIFT of Fort Lauderdale, Florida and CHRIS were recently in Calgary visiting PCI. SWIFT told PCI of being interviewed by the FBI. They also stated that GIANCANA has a home in Palm Beach, which he tried to sell to CHRIS for \$80,000. Both CHRIS and SWIFT had been to this home. They also advised that GIANCANA had stated "I'm through. The FBI has got me on the ropes. I can't do anything". ✓

FIRST NAME UNKNOWN

PCI said that about 2 years ago, he went to dinner in Chicago with (FNU) SIBILAROS (ph). This individual is a furniture dealer who furnished the home of ACCARDO and other hoodlums in Chicago. They ate at a big restaurant owned by a man with a common Italian name and it is located near the Hotel Drake. The owner of the restaurant and SIBILAROS introduced PCI to Captain HERSHIE SMITH and Lieutenant (FNU) GENTILE of the Chicago PD and said they were friends of SAM. GENTILE is no longer a member of the PD. ✓

PCI also advised that JOE PIGNATELLO who runs the "Coach and Four" in Las Vegas is the chauffeur and general handyman for GIANCANA when GIANCANA is in Las Vegas. ✓
