FROM INFORMATION FURNISHED BY CG 6486-C* AND CG 6576-C* IT HAS BEEN LEARNED THAT GIANCANA IS LIMITING HIS CONTACTS AT THIS TIME TO PERSONS KNOWN TO BE TRUSTWORTHY. IT IS FURTHER FELT AT THIS TIME THAT GIANCANA IS NOT EVEN LETTING THESE PEOPLE KNOW HIS INTENTIONS FROM RECENT INFORMATION RECEIVED CONCERNING HIS TRAVELS. AS POINTED OUT IN MY TEL INFORMATION WAS RECEIVED INDICATING GIANCANA WAS FLYING "EAST TO SEE HER" APPROXIMATELY TWO WEEKS AGO.
