Jeanette Braga

The West German Federal Criminal Police received the following anonymous letter, postmarked in Chicago November 8, 1963: "Counterfeit money sent to Hermine Braga, Wissman 26 Bettenhausen, Germany from Jeanette Braga, girl friend of Charles English, hoodlum and Sam Giancana Chicago. Miss Braga in Chicago holding out cash. Hoods calling up."

German Police inquiry reveals Hermine Braga, neo Willig, born July 28, 1932, Stuttgart, Germany, has been visiting her mother at 26 Wissmannstrasse, Kassel, Germany, since August, 1963; that she came from Chicago with 2-3 year-old daughter; that she has relations with American soldiers in Kassel area; that she allegedly receives dollar bills in letters. She is described as appearing about 23 years old, five feet three inches, black hair, fine face.

The United States Treasury representative at Frankfurt, Germany, has been furnished the foregoing information.
