SAMUEL M. GIANCANA, AKA, AR. DAILY SUMMARY.

CG 6498 PC ADVISED TODAY THAT HE HAS BEEN INFORMED BY JOHN DIARCO, DEMOCRATIC WARD COMMITTEEMAN, FIRST WARD, THAT SAM GIANCANA HAS INSTRUCTED THAT MOVES BE MADE TO MAKE ALDERMAN ROBERT L. MASSEY, 36TH WARD, A LOCAL JUDGE, PCI ADVISED THAT MASSEY IS NOT TRUE NAME OF THIS INDIVIDUAL, THAT HE IS ITALIAN AND THAT AT LEAST ONE OF HIS BROTHERS IS A MEMBER OF THE HOODLUM ELEMENT IN CHICAGO WHO IS CLOSE TO GIANCANA. PCI DESCRIBED MASSEY AS WORST TYPE OF POLITICIAN WHO CAN BE COUNTED ON BY GIANCANA AND OTHER HOODLUMS FOR PRACTICALLY ANYTHING. PCI FEELS SLATING OF MASSEY ON DEMOCRATIC TICKET WHICH IS TANTAMOUNT TO ELECTION WOULD BE GREAT BLOW TO CAUSE OF JUSTICE SINCE MASSEY WOULD SERVE HOODLUMS IN BEST TRADITION OF OTHER SUCH JUDGES SUCH AS SORRENTINO, WEISS, RYAN, KOWALSKI AND OTHERS. FURTHERMORE FROM NOW ON SINCE PASSAGE OF JUDICIAL REFORM AMENDMENT SUCH ELECTION MEANS LIFETIME TENURE UNLESS ELEVATED TO FEDERAL BENCH.

IN VIEW OF ABOVE, INVESTIGATION BEING CONDUCTED TO DETERMINE COMPLETE BACKGROUND OF ALDERMAN MASSEY WITH PARTICULAR REFERENCE TO DETERMINE TRUE NAME AND IDENTITY OF HOODLUM BROTHER.
