SAMUEL M. GIANCANA, AKA. AR. DAILY SUMMARY.

CG 6576-C* ADVISED THAT A PARTY WAS HELD AT THE ARMORY LOUNGE ON SUNDAY, DECEMBER 15 LAST FOR SINGER VIC DAMONE AND APPARENTLY HOSTED BY GIANCANA. SOURCE ADVISED PAT MARCY IN CONVERSATION WITH ASSOCIATES THOUGHT THIS TO BE A VERY POOR PLACE TO HOLD SUCH A PARTY AND FELT THAT SUCH A CELEBRATION WOULD ONLY CAUSE POOR PUBLICITY FOR DAMONE AND MORE PUBLICITY FOR GIANCANA.

THIS WOULD APPARENTLY SUBSTANTIATE THAT INFORMATION RECENTLY FURNISHED BY CG 6656-C-TE THAT DAMONE APPEARED AS THE OPENING NIGHT ENTERTAINER AT THE NEW CHEZ PAREE IN CHICAGO SEVERAL WEEKS AGO BECAUSE OF A REQUEST MADE OF DAMONE BY GIANCANA.

BUREAU PERMISSION REQUESTED TO INTERVIEW DAMONE PRIOR TO HIS DEPARTURE FROM CHICAGO.
