PHYSICAL SURVEILLANCE IN VICINITY ARMORY LOUNGE REFLECTED GIANCANA MET DECEMBER 23 LAST WITH JACK CERONE, SAM ROSA, CHUCK ENGLISH, BUTCH BLASI, ROY TAGLIA, AND QUEENIE SIMONELLI FOR PERIOD OF SEVERAL HOURS. ALSO IN ATTENDANCE WAS ONE RALPH MASSUCI. MASSUCI HAS BEEN IDENTIFIED AS BROTHER OF ALDERMAN ROBERT MASSEY, 36TH WARD WHO CG 6576-C* HAS ADVISED IS CLOSE TO GIANCANA AND WHO IS BEING PUSHED BY GIANCANA FOR A LOCAL JUDGESHIP. CG 6498-PC HAS ADVISED THAT MASSEY RECEIVES HOODLUM BACKING BECAUSE OF RELATIONSHIP BETWEEN GIANCANA AND MASSEY'S BROTHERS. MASSUCI'S REPORTEDLY OPERATE BOOKMAKING OPERATION ON WEST SIDE AND ARE PRESENTLY UNDER INVESTIGATION BY CHICAGO DIVISION IN THIS REGARD. *V*
