OLACOSA NOSTRA

On 10/25/68, NY 6436-C-TE (member source) advised that about 10 years ago CARLO GAMBINO had a group in Baltimore numbering about 50. FRANK CORBI is the Capodecina having taken over for LOUIDICIENA (LUIGI MORICI). Because of limited contact the informant is unable to name these persons. The number 50 seems to be excessively high and it is unlikely that the CI will ever be able to name a large fraction of this number. However, in an attempt to reconcile this group, Baltimore is requested to forward to the NYO the names, photographs and a very brief statement of current activities of named members, suspected members and all known BAO LCN associates who possibly could be members of LCN.

In the near future informant may visit Baltimore and if so he will then be in a position to identify additional members.

FRANK CORBI's son was married in 1966 in Baltimore. Any photographs of hoodlums attending this affair, other weddings, wakes, funerals and social functions should be sent to the NYO. These will be shown to the informant for possible identification.

Since informant has advised that CORBI's brother (probably referring to PASQUALE CORBI) was a LCN member photographs of all his brothers should likewise be sent.
