Enclosed are nine copies of a LHM dated and captioned
as above containing information from [WF 1442-S*.] (S)

It is noted that Mr. I. IRVING DAVIDSON, public relations agent, 1612 K Street, N.W., Washington, D.C., telephonically furnished substantially the same information to SA HAROLD RUBENSTEIN on 4/10/67 as set forth in the enclosures (attributed to DREW PEARSON). DAVIDSON added that his concern in this matter is that various business interests he represents through several individuals in Haiti will suffer as a result of the chaos if Haitian President FRANCOIS DUVALIER dies suddenly. It is further noted that DAVIDSON in the past has expressed his close relationship with PEARSON and has indicated furnishing PEARSON with information similar to that contained in the enclosure. It would, therefore, appear that the "good friend" mentioned by PEARSON in the enclosure is DAVIDSON.

The enclosure is classified "Secret - No Foreign Dissemination" since it reveals our investigative interest in a representative of a foreign government, a foreign diplomatic official, a foreign diplomatic establishment and since data therein could jeopardize the identity of the informant.

On April 10, 1967, an informant, who has furnished reliable information in the past, advised [that he learned from Enrique Tejera-Paris, Ambassador at the Embassy of Venezuela, Washington, D.C.] of a conversation he had on that date with Drew Pearson, newspaper columnist. (X)

During the above conversation Pearson advised [Tejera] (S) that he received information from a "good friend" of his just returned from Haiti, who is also a good friend of Haitian President Francois Duvalier. This information was to the effect that Duvalier is very ill, suffering from diabetes and heart trouble, weighing only 100 pounds and is expected to die within the next six months. Pearson further advised (S) [Tejera] that his friend advised that Duvalier is bitter and (X) will do nothing; after his death, certain factions of Haitians will be fighting each other with chaotic results.

Pearson stated that he suggested to President Johnson that this be a matter to be discussed at the summit conference to be held at Punta del Este, Uruguay. [Tejera commented that this suggestion was "all right but not with too many there."] (S)

[Tejera, during the above conversation] (S) was critical of the coming summit conference, described it as an "instant conference, pre-cooked, everyone knowing already what they are going to say, a meeting of 21 chiefs of state with no dramatics." (X)
