I. Irving Davidson is known to your office, since he has called on you within the past two weeks and provided information relating to Dominican matters. He has recently registered as an agent of President Balaguer of the Dominican Republic and has been registered as an agent for President Duvaller of Haiti for several years. He has furnished the Eureau with information over a number of years and on no occasion has it ever been determined that he intentionally provided unreliable data. However, it has been noted that he will frequently furnish information which will best serve his own purposes as a registered agent for his foreign principals.

For your information, there is attached a copy of a letter which Mr. Davidson addressed to Associate Director Tolson under date of 3/12/68. He is being advised that it will not be possible to comply with the request in his letter.

You should be most alert for any information received through your sources in the Dominican Republic relating to the contents of Mr. Davidson's communication. You should be specifically alert to any information indicating that President Balaguer will in fact make an official visit to the United States and during the course of such visit ask for the opportunity of meeting personally with me.
