to the informant. CAMARENA stated the Ambassador (possibly Dominican Ambassador HECTOR GARCIA GODOY) has just been on this". (GODOY) traveled to DR on 3/11/68 and returned to New York City 3/14/68 per WF 984-S*). CAMARENA advised DAVIDSON that info concerning the matter had been sent to Santo Domingo, DR. CAMARENA told DAVIDSON that GODOY vanted to obtain DAVIDSON's opinion on the matter because of DAVIDSON's closeness to Dominican President JOAQUIN BALAGUER. DAVIDSON agreed to visit the Dominican Embassy in twenty minutes.

At approximately 4:57 p.m., 3/14/68, DAVIDSON telephonically advised SA GERALD B. NOLAN that he, DAVIDSON, had been in DR for several days recently. Further, that DAVIDSON requested New York Office of FBI telephone number because he wanted to discuss with SA FRANK O'BRIEN some unfounded rumors circulating in Santo Domingo, DR, which rumors were also known to ENRIQUE A. GARCIA, JR., in New York City. DAVIDSON feared that GARCIA would be making "lots of noise" concerning the rumors. (DAVIDSON stated he was not further explaining matter to WFO since he planned to discuss matter with New York Office.)

At 5:20 p.m., 3/14/68, WF 984-S* ascertained that CAMARENA called SA FRANK O'BRIEN of New York Office and at CAMARENA's request, arranged to meet SAs O'BRIEN or VON ECKARDT or both at CAMARENA's New York City apartment, 819 West 180th Street, at 11:30 a.m., 3/15/68. CAMARENA noted that he was making this appointment to see SA O'BRIEN at suggestion of DAVIDSON.

DAVIDSON telephonically advised SA NOLAN on 3/15/68, that he was requested to meet with Dominican Republic Ambassador Dr. HECTOR GARCIA-GODOY in the late afternoon of 3/14/68.

GODOY informed DAVIDSON of his (GODOY's) concern over communication received by him from Santo Domingo to the effect there was going to be an invasion of the DR and possibly an assassination of Dominican President BELAGUER. DAVIDSON stated he had heard this rumor some ten days ago and suggested to GODOY that the Embassy should check this out with SA

DAVIDSON also advised that ENRIQUE GARCIA had the same rumor and furnished it to the New York Office, FBI. DAVIDSON described the source of the rumor as a bunch of "bums" (not further described) in New York, New York, in whom ENRIQUE GARCIA has trust; but whom DAVIDSON does not trust.

DAVIDSON stated he was scheduled to enplane for New Orleans, Louisiana on 3/14/68, but delayed this trip to 3/15/68, to meet with GODOY.
