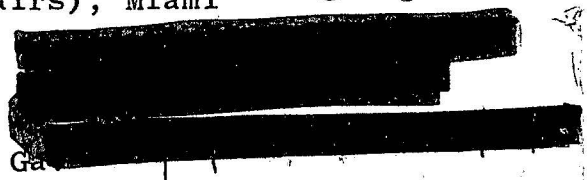

Miami has instructed logical sources, MM 635-S, and MM 639-S, both of whom have had a number of contacts in the past with FIORINI, to attempt to develop information regarding the current activities of the IACB and FIORINI. *(u)*
