Character: ANTI-RACKETEERING

Synopsis: Background information developed and set out. Subject reportedly obtained \$400,000 loan through ALLEN DORFMAN from Teamster's Union Pension Fund for Auburn Toy Company, Deming, New Mexico. WEINER, close friend and confidant of FELIX ALDERISIO (deceased), reportedly may know whereabouts of ALDERISIO's hidden assets of cash and stolen jewelry. Subject and "TURK" TORELLO reportedly have taken over trucking business of VITO DI ZONNO who allegedly "stuck" WEINER with \$35,000 bad check issued to State of Illinois. Subject allegedly a "courier" for the "Outfit" who makes runs to Las Vegas, Houston, New York and Washington, D.C. WEINER observed in attendance at wake of FELIX ALDERISIO on September 26 - 28, 1971. Subject allegedly paid \$1,000 to officers on Niles, Illinois Police Department to square traffic citation and assault of officer, which citation and assault are no longer contained in Niles official police records. WEINER also paid Niles Police Department officers to go to Scottsdale, Arizona to get his step-son, who was being held there on stolen car and narcotics charges.
