On August 19, 1973, CG T-1 stated that he has been in contact with IRV WEINER and was assured by WEINER that WEINER's present difficulty with the Federal government is going to be handled in the proper fashion and that he, WEINER, is apparently not worried about it. CG T-1 advised it is possible to interpret WEINER's remarks in a number of ways; however, CG T-1 feels that WEINER really was telling him that "the fix is in" and that WEINER had made some kind of a deal which would enable him to survive and intensive Federal Grand Jury investigation into a Central States Teamsters Union Pension Fund loan to a plastics firm partly owned by WEINER in Deming, New Mexico. According to CG T-1, WEINER is receiving legal representation in this matter from Attorney ALBERT JENNER, who, WEINER states, is close to United State's Attorney JAMES THOMPSON.
