On May 8, 1961, CG 6441-C\* advised that he learned that "Milwaukee Phil" ~~ALDERISIO~~ and his associates had abandoned plans to utilize the second floor at 19 East Chestnut for a headquarters and instead have taken up headquarters in the offices of the ~~Preferred Cigarette Vending Incorporated~~, 2757 West Fullerton Avenue, which according to the informant is a vending machine company operated by ~~ALDERISIO~~. Also utilizing these offices on a permanent basis at this time are ~~SAM BATTAGLIA~~, ~~LEO RUGENDORF~~ and ~~IRV WEINER~~.

In view of the above no further efforts will be made to install coverage at 19 East Chestnut.
