ALDERISIO feels that WEINER makes an excellent witness because he is "an (obs) actor." BIEBER questioned whether they might be using WEINER as a witness too often, and mentioned that he had just been used again in the DORFMAN case in San Francisco. He indicated, however, that if WILLIAMS felt that he wanted to use WEINER, that this, perhaps, should be done.

BIEBER then informed ALDENSIO concerning his relationship with LOUIS <u>ARIPPO</u>, head of the Criminal <u>Division of the Cook County State's Attorney's Office</u>... BIEBER indicated, "He's a good kid, he's my friend. He's my friend. You know his father." ALDERISIO indicated that the father of LOUIS GACIOPO is a former alderman in Chicago, who "comes to be any time he needs anything, don't say nothing to nobody, now," It is noted that CG 6498-C-TE advised on 2/2/65 that the elder GARIPPO will again be slated for alderman of the 35th Ward of Chicago, following a secret ballot of precinct captains, which took place on the evening of 2/1/65. The 36th Ward is a ward in which the influence of the hoodlum organization in Chicago is very great.

BIEBER then indicated that he was with GARIPPO on the morning of 1/29/65, and that GARIPPO is "trying to help the GRIECO boys." It is noted that JOSEPH and DONALD GRIECO have been indicted for intimidating one of their "juice" victims. ALDERN SIO questioned whether GARIPPO knows the GRIECO brothers, and was informed, "Knows them? He went to the wedding." When ALDERISIO then asked whether GARIPPO can be of any help to the GRIECO brothers, BIEBER stated, "We could have been through with it already, but that (obs) FLYNN was in on it. I told GARIPPO to get the (obs) off of the case. He's a dirty (obs), that FLYNN is." The reference to FLYNN is to Assistant Cook County State's Attorney JAMES/FLYNN, who is one of the most conscientious prosecutors in the Cook County State's Attorney's Office.

BIEBER then informed ALDEN SIO, "We may need some help for the GRIECOS too. I mean, maybe you'll have to
