JAMES WEINBERG, WITH ALIASES, ET AL; TFIS. UNITED STATES TREASURY REPRESENTATIVE, MEXICO CITY, HAS CONTACTED THIS OFFICE TO OBTAIN FROM BUREAU CRIMINAL RECORDS OF DANNY LARDINO AND PAUL AND EDWARD JONES, CHICAGO RACKETEERS PRESENTLY IN MEXICO. INFORMATION THIS OFFICE IS THAT REQUEST IS BASED ON DESIRE OF TREASURY REPRESENTATIVE TO EFFECT REMOVAL OF NAMED INDIVIDUALS FROM MEXICO UNDER TERMS OF CONFIDENTIAL WORKING AGREEMENT WITH CERTAIN MEXICAN POLICE WHEREBY ESTABLISHMENT OF EXISTENCE OF UNITED STATES CRIMINAL RECORD IS SUFFICIENT TO WARRANT REMOVAL FROM MEXICO AS UNDESIRABLE ALIENS. WITH FOREGOING IN MIND, BUREAU REQUESTED TO GIVE CONSIDERATION TO FORWARDING STATED CRIMINAL RECORDS TO MEXICO CITY. NO PROSECUTION OF NAMED INDIVIDUALS IN THE UNITED STATES CONTEMPLATED BY TREASURY DEPARTMENT BUT ACTION FOLLOWS POLICY OF LOCAL TREASURY REPRESENTATIVE TO KEEP UNITED STATES HOODLUMS OUT OF MEXICO, TAKING AFFIRMATIVE ACTION WHERE NECESSARY.
