The Bureau teletype advised that the Bureau's confidential sources in Mexico had received information to the effect that Paul Roland Jones, a member of the James Weinberg Gang, was arrested. July 28, last, by a Mexico official who is confidential contact of a United States Treasury official in Mexico City. The arrest was an unauthorized action of the Confidential informant of the Treasury official who is investigating the activities of the Jack Guzik mob of Chicago, in Cooperation with the Civil Atlache, and also because of prior independent interests. A civil Atlache was present at the interview with Jones. However, the Atlache's identity was not revealed. During the course of these interviews Jones revealed certain extensive gambling activities in Mexico City and also other activities of the Weinberg mub in Dallas, Texas and Lower California, at which time Jones implicated Marcus Lipsky, Poul Labricula, James Weinberg, Sam Yaris, Phil Mann and Lou Schneider. According to Jones, Schneider was the active monager of the Gambling Casino in Mexico City after it was established by Jones and E. L. (Buddy) Satcher.

Mexican government officials figured in the gambling pay off and were identified by Jones as follows: Roso Bome 2. Bovernor of the Federal District; General Emilio Baie Serra, Chief of the Investigative Unit, Gobernacion; Col Perez Ortega, Assistant Chief of Federal District Police, and other Mexican officials not yet definitely identified. According to Jones, one Joe Green acted as the pay-off man to the Mexican officials. It is anticipated Green will be identified more fully during subsequent investigation. The Bambling Casino in Mexico City is reported to have opened about December, 1945, and was closed March, 1946, according to Jones, due to the fact that the venture did not pay in lieu of welching of Mexican losevs and the high Cost of protection.

In these interviews JONES devied traffic in Stolen jeweleng to Mexico or any gambling operations at the Reforma Hotel. He indicated that he would be willing to talk concerning the Weinberg Gang activities in Stolen jeweleng and Stolen automobiles in the United States, but expressly Stipulated that he would give no declaration of this information would bring about an F.B. I investigation. He gave no appearances of talking freely in the basis of a bargain reached with the U.S. Treasury officials who wished information on the GUZIK meb and their activities from an Internal Kevenne Standpoint, counterfeiting and Similiar matters in the United States.
