Re interrogatory IV, while the information was not furnished by MM 987-C-TE, it should be noted that serial 971 of Miami file 92-88, Bufile 92-2781, on TRAFFICANTE, also enclosed herewith, disclosed that PCI, CARLOS ACOSTA, JR., advised SA SCRANTON on 10/29/63, that he heard that anti-CASTRO groups can purchase arms and ammunition from Mafia through TRAFFICANTE and TRAFFICANTE will finance purchase upon evidence group is taking direct action against CASTRO.

It is noted that re Miami nitel dated 7/1/75, disclosed that informant as of 6/30/75, and prior thereto, had been furnishing information to the Dade County, Florida Department of Public Safety and that Investigator RAUL DIAZ was working closely with informant.

It is also noted that DIAZ recently stated in general conversation with SA JOSEPH S. DAWSON that he was scheduled to appear before the Senate Intelligence Committee in Washington, D.C., during the week of 5/2/76, but he did not disclose the reason therefore.
