ReBulet to CIA dated 5/9/61, which requested CIA recontact their source of information concerning alleged Cuban intelligence agents in the Miami area as mentioned in CIA's letter to the FBI dated 4/28/61, classified secret; Bulet to Miami dated 6/23/61, advising CIA stated the source of mentioned information was JOSE MANUEL ALEMAN, 3300 Collins Avenue, Miami Beach, Florida. (u)

JOSE ALEMAN furnished the following information to SA MAURICE F. FARABEE on July 12, 1961:

ALEMAN said the identity of most of the alleged Cuban intelligence agents in Miami had been furnished him shortly before Christmas, 1960, by MANUEL SELGAS, an employee for the City of Miami at the Bayfront Park, Miami, FL, and by an unrecalled friend of SELGAS who is a Spaniard. ALEMAN said SELGAS and his friend obtained most of their information from overhearing conversations at the park. ALEMAN said he could not recall any details furnished by SELGAS and his friend about the alleged agents. SELGAS is the subject of a closed PSI case in the Miami Office (Bufile 134-7245; Miami File 134-276).

Except for PAEZ and PLATA, the other persons are the subject of open or closed cases in the Miami Office and ALEMAN contributed no additional pertinent information to that already reported. In regard to JORGE PAEZ and ANDRES PLATA, ALEMAN could furnish no information to substantiate the allegations, but merely suspects they are agents because they were strong followers of FIDEL CASTRO during the early days of the CASTRO regime. For this reason, cases are not being opened on PAEZ and PLATA.

Miami will interview SELGAS and his friend for all pertinent information concerning those persons on whom ALEMAN did not furnish information. If specific information is obtained it will be reported in form suitable for dissemination.
