Information contained on the carbon paper furnished by McCREADIE was processed by the FBI Laboratory which made photographic copies of the typewriting to facilitate in translation of the Spanish contained thereon. Translation was made by Translator ELEANORE M. SCHOENBERGER of the Miami Office.

The letterhead memorandum is classified "Confidential" to protect identities of the informants whose effectiveness might be compromised if their identities were disclosed.
