On 5/23/58, NORMAN ROTHMAN, who is operating numerous slot machine concessions in central Cuba and who maintains the base of his operations in Camaguey, Cuba, advised that WILLIAM PAYNE MOOREFIELD had previously been employed by him as a slot machine mechanic. He stated, however, that he had caught MOOREFIELD shortchanging him on the proceeds from the slot machines and, as a result, he had told MOOREFIELD to get out of Cuba permanently. ROTHMAN said that immediately thereafter, MOOREFIELD, together with his wife and daughter, left Cuba via and the mill car ferry and went to Miami. ROTHMAN said he does not know MOOREFIELD's exact address in Miami but that from information he has received MOOREFIELD is still there. For the information of the Miami Office. WILLIAM PAYNE MOOREFIELD is HAV-29 and formerly was an informant of the Salt Lake City Office, their symbol number SU 351-C. He had worked in recent years as a slot machine mechanic and dealer in the Las Vegas, Nevada, area. He came to Cuba in July, 1957, and was employed as a slot machine mechanic for NORMAN ROTHMAN, FBI #125825-B. His exact whereabouts have not been known since his departure from Cuba in February, 1958. Since there is no indication that he intends to regurn to Cuba, Legat, Havana, is discontinuing this individual as An informant.
