SAMUEL M. GIANCANA, AKA, AR. DAILY SUMMARY. CG 6443-C
 ADVISED INSTANT THAT LESLIE KRUSE, CHICAGO TH, HAD TO MAKE
 AN EMERGENCY TRIP TO MIAMI AND PALM BEACH THIS DATE TO
 "SELL HIS HOME IN LAKE WORTH, FLORIDA,." CG 6486-C* ADVISED
 THAT GIANCANA, ON FEBRUARY 8 LAST DURING EARLY MORNING, WAS
 IN CONFERENCE WITH ONE "POTSY," BELIEVED TO BE MORRIS PEARL,
 CHICAGO GAMBLER, AND MUCH OF DISCUSSION CONCERNED LAS VEGAS.
 PEARL STATED HE HAD RECENTLY BEEN IN CONTACT WITH SID WYMAN,
 OF THE DUNES HOTEL, LAS VEGAS, WHO ADVISED PEARL THAT HE,
 WYMAN, OWNS 50% OF THE DUNES. OFFERED SOME POINTS TO PEARL, WHO
 IN TURN OFFERED TO CUT IN GIANCANA ON THE DEAL IF HE WAS
 INTERESTED. GIANCANA EVINced AN INTEREST, WHEREUPON PEARL
 STATED HE WOULD LOOK INTO THIS FURTHER. DISCUSSION TOUCHED
