 SAMUEL M. GIANCANA, AKA, AR. DAILY SUMMARY. CG 6486-C* ADVISED LATE LAST NIGHT AND EARLY THIS MORNING THAT GIANCANA HELD A LENGTHY CONFERENCE WITH INDIVIDUAL BELIEVED TO BE LOU BRADY FROM CLEVELAND. CONVERSATION COVERED BY EXCESSIVE BACKGROUND NOISE AND TRANSCRIPTION NOT COMPLETE. TEXT OF CONVERSATION INVOLVED A PENDING NINE MILLION DOLLAR PURCHASE OF POINTS IN A HOTEL BELIEVED TO BE IN RENO, NEVADA BY GIANCANA. ONE PARTY THIS GROUP IS POSSIBLY DEALING WITH IS GEORGE SAX, OWNER OF SAXONY HOTEL IN MIAMI BEACH, FLORIDA. NO DEFINITE COMMITMENTS WERE ARRIVED AT DURING CONVERSATION. EFFORTS CONTINUING TO CLEAN TAPE TO OBTAIN MORE CLEAR TRANSCRIPTION. CG 6512-C ADVISED THIS DATE THAT ONE CARL MILANO, CLEVELAND HOODLUM, ARRIVED CHICAGO FROM CLEVELAND TWO WEEKS AGO SPECIFICALLY FOR A CONFERENCE WITH GIANCANA. BRADY AND MILANO KNOWN TO BE CLOSE. PRETEXT INQUIRY TO LOCATE FRANK ESPOSITO AT CHICAGO NEGATIVE. MIAMI ADVISED BY SEPARATE COMMUNICATION. GIANCANA CONSIDERED ARMED AND DANGEROUS.
