DAILY SUMMARY. CG 6538-C-TE ADVISED THAT HE HAS ASCERTAINED THAT IN CICERO, ILLINOIS, THERE REMAIN ONLY THREE PLACES WHICH ARE PERMITTED TO OPERATE ON AN OPEN BASIS, AFTER THE NORMAL CLOSING HOURS. THESE ARE THE STOPLITE LOUNGE, THE TURF LOUNGE, AND THE MGM LOUNGE, ALL KNOWN TO BE GIANCANA ORGANIZATION ENTERPRISES. THE MGM IS A KNOWN GAMBLING ESTABLISHMENT OPERATED FOR GIANCANA BY NICK KOKENES, WHO, ACCORDING TO CG 6343-C\*, WAS FORCED TO TURN OVER HIS PLACE TO SAM BATTAGLIA, GIANCANA'S REPRESENTATIVE FOR THE WESTERN SUBURBS. THE TURF LOUNGE IS OPERATED BY JOSEPH AIUPPA, CHICAGO TH, AND SPECIALIZES IN BURLESQUE. THE STOPLITE IS KNOWN TO BE A HANGOUT FOR GIANCANA AND WELL KNOWN CHICAGO AREA JEWEL THIEVES AND BURGLARS. (u)
