DAILY SUMMARY. CG SIX FOUR FIVE SEVEN DASH PC ADVISED YESTERDAY THAT SHE ATTEMPTED TO MAKE CONTACT WITH GIANCANA AT THE ARMORY LOUNGE, FOREST PARK, AND WAS UNSUCCESSFUL. DOMINIC BLASI, GIANCANAS NUMBER ONE LT. ADVISED INFORMANT THAT GIANCANA IS OUT OF TOWN. NOTED, HOWEVER, THAT GIANCANA WAS OBSERVED BY A FRIEND OF THE INFORMANT IN THE VICINITY OF THE ARMORY. HIS AUTOMOBILE WAS OBSERVED YESTERDAY BY BUAGENTS ONE BLOCK FROM ARMORY. NOTHING OF PERTINENCE WAS DEVELOPED.

INFORMANT STATED SHE ATTEMPTED TO CONTACT GIANCANA FOR THE PURPOSE OF APPRISING HIM OF THE FACT THAT HER YOUNGEST CHILD, AGE TWO, HAS CANCER OF THE KIDNEY, AND WAS DESIROUS OF GETTING FINANCIAL ASSISTANCE FROM HIM. NOTED THAT GIANCANA BELIEVES THIS CHILD TO BE HIS. BLASI ADVISED INFORMANT HE WOULD ATTEMPT TO CONTACT GIANCANA. ARMED AND DANGEROUS. (u)
