DAILY SUMMARY. CG 6241 - C ADVISED YESTERDAY THAT HE IS SCHEDULED TO START AS DOORMAN AT NEW SAHARA MOTEL ON OPENING DAY WHICH IS TO BE IN A FEW WEEKS. STATED HE HAS LEARNED THAT IN ADDITION TO GIANCANA INVESTING IN THE OPERATION OF THE SAHARA MOTEL, "SLIM," PROBABLY BUS ALEX, IS ALSO INVOLVED. IT HAS BEEN ASCERTAINED FROM THE COOK COUNTY RECORDERS OFFICE THAT THE PROPERTY AT THE SAHARA IS HELD IN TRUST TO THE EXCHANGE NATIONAL BANK, CHICAGO. NOTED THAT CG 6486 - C\* ADVISED SEVERAL MONTHS AGO THAT LOU BRADY, IN DISCUSSION A FINANCIAL INVESTMENT IN THE AMOUNT OF TEN MILLION DOLLARS WITH GIANCANA, STATED THAT JEROME SAX, OF THE EXCHANGE NATIONAL BANK, WAS INTERESTED IN DEALING IN THIS INVESTMENT. EXCHANGE NATIONAL BANK HAS ALSO BEEN UTILIZED BY ROSS PRIO IN SOME OF HIS TRANSACTIONS. (u)
