SAMUEL M. GIANCANA, AKA., AR. DAILY SUMMARY.

NORMAN GLUBOCK (PROTECT IDENTITY) ADVISED YESTERDAY THAT HE INTERVIEWED MANNY SKAR, SAHARA MOTEL NORTH, REGARDING THAT OPERATION, AND SKAR ADVISED THAT HE IS THE SOLE OWNER AND OPERATOR OF THAT ESTABLISHMENT. HE DENIED THAT HE HAD ACCEPTED A CENT OF HOODLUM MONEY FOR THE MOTEL BUT DECLINED TO FURNISH HIS SOURCE OF FINANCING FOR THE MOTEL, WHICH HE STATES COMES TO A TOTAL COST OF TEN POINT FOUR MILLION DOLLARS. SKAR DENIED TO GLUBOCK THAT HE EVER MET SAM GIANCANA, STATED HE DOES NOT KNOW THIS INDIVIDUAL, SAID "I'LL TAKE A LIE DETECTOR ON THAT FACT." ADMITTED KNOWING MARSHALL CAIFANO, (GIANCANA LIEUTENANT), STATED STRICTLY SOCIAL ACQUAINTANCE. (u)

CG 6457 - PC ADVISED INSTANT THAT SHE WAS CONTACTED BY DOMINIC BLASI OVER THE WEEKEND REGARDING THE STATUS OF HER SON, SUFFERING FROM CANCER. GIANCANA GAVE BLASI INSTRUCTIONS TO PASS TO INFORMANT THAT SHE WAS TO GO TO A CERTAIN DOCTOR WHO WOULD "TAKE CARE OF THE SITUATION," HOWEVER, THE INFORMANT REFUSED TO DO SO, STATING THAT IF SHE DID NOT OBTAIN DIRECT FINANCIAL ASSISTANCE FROM GIANCANA SHE WOULD SEE A LAWYER. BLASI WARNED THE INFORMANT THIS WOULD BE MOST IMPRUDENT AND UNWISE, THAT HE WOULD CONTACT GIANCANA AGAIN. (u)
