DAILY SUMMARY. CG 6514 - PC - TE ADVISED INSTANT THAT HE STILL CONSIDERS HIMSELF AS AN OPPONENT TO THE CHICAGO SYNDICATE AND SPENDS HIS LIFE PROMULGATING THE CAUSE OF THE LEGITIMATE ITALIAN AMERICAN CITIZEN. HE CONTINUES TO DENY ANY ASSOCIATION WITH GIANCANA AND HIS ORGANIZATION AND POINTED OUT THAT HE HAS BEEN BLACKBALLED FROM FUTURE POLITICAL ACTIVITY SINCE HE REFUSED TO GO ALONG WITH THE OUTFIT WHEN HE WAS WARD COMMITTEEMAN OF THE FIRST WARD, NOW JOHN DIARCO'S, IN 1952. STATED THAT AT THAT TIME HE WAS OFFERED \$10,000 BY JACK GUZIK, FORMER LEADER OF THE SYNDICATE, NOW DECEASED. HE REFUSED THE OFFER, AND HAS BEEN OUTSPOKEN IN HIS EFFORTS TO REMAIN LEGITIMATE. INFORMANT STATED HE HAS BEEN PROMISED THE NEXT OPENING FOR COUNTY COMMISSIONER OF COOK COUNTY, BY MAYOR DALEY. INFORMANT STATES "I HAVE LOTS OF STORIES I COULD TELL YOU," BUT WOULD NOT ELABORATE ON THEM AT THIS TIME, NOR WOULD HE EXPLAIN THE MEANING OF THAT REMARK. INFORMANT LEFT DOOR OPEN FOR FUTURE CONTACTS.
