LUMS THROUGH BUSINESS DEALINGS IN JEWELRY BUSINESS, ADVISED
YESTERDAY HE IS WELL ACQUAINTED WITH MANNY SKAR, OWNER OF RECORD OF
THE SAHARA INN NORTH MOTEL, STATES IN HIS OPINION, SKAR IS NOT
FINANCIALLY EQUIPPED ENOUGH TO AFFORD SUCH AN ESTABLISHMENT,
HOWEVER, INFORMANT FEELS THAT THE CHICAGO ORGANIZATION, VIA
GIANCANA, DOES NOT BELIEVE AT THIS TIME THAT AN ESTABLISHMENT SUCH
