LV 10-C advised SA TOOLSON on 6/11/62, that on 6/9/62, NICHOLAS DANALFO, aka "PEANUTS," made reservations at the Desert Inn Hotel for four people under the name of FLOOD, who were to call him upon arrival. On 6/11/62, FRANCINE, MARIAN and ROSE D. FLOOD all checked into the Desert Inn from 4962 North Adams Boulevard, Chicago. They were assigned Rooms 125 and 127. Subsequently the females were in touch with PHYLLIS MC GUIRE at her residence in Paradise Valley. On 6/11/62, a telegram was sent from one of the above rooms to Mr. SANTI CAMPANELLA, JR., Westford Road, Providence, Rhode Island, which read as follows:

"Hi - Am in Las Vegas - Will be home Monday pight." signed "Love you, Homespun."
