Re Indianapolis airtel 6/26/62, reflecting JOHN FORMUSA was at his residence in Gary, Indiana. (U)

Efforts by the Las Vegas Office to identify the individual who contacted PHYLLIS MC GUIRE, as reported by LV 72-C*, have been unsuccessful. Discreet inquiry of Intelligence Units of the Clark County Sheriff's Office and Gaming Control Board, as well as inquiry in northern Nevada around the Cal-Neva Lodge, has failed to develop any information which reflects that JOHN FORMUSA has been in the Nevada area during the past few months. (U)

LV 10-C advised SA R. BURNS TOOLSON on 6/13/62, that shortly before PHYLLIS MC GUIRE left Las Vegas she was in touch with a ROSE FLOOD, who was a guest at the Desert Inn Hotel. (U)

LV 10-C advised SA TOOLSON on 6/6/62, that a photograph and article appeared in a Chicago newspaper concerning GIANCANA and PHYLLIS MC GUIRE. This caused quite a disturbance at the Desert Inn Hotel, where the McGuire Sisters were then appearing. Numerous telephone calls from newspaper reporters all over the country were received at the hotel requesting to speak to PHYLLIS MC GUIRE. MC GUIRE and her manager put out the story that GIANCANA was just one of her many admirers, that they were not married, and are just casual friends. (U)

LV 10-C advised SA TOOLSON on 6/11/62, that on 6/9/62, NICHOLAS DANALFO, aka "PEANUTS," made reservations at the Desert Inn Hotel for four people under the name of FLOOD, who were to call him upon arrival. On 6/11/62, FRANCINE, MARIAN and ROSE D. FLOOD all checked into the Desert Inn from 4962 North Adams Boulevard, Chicago. They were assigned Rooms 125 and 127. Subsequently the females were in touch with PHYLLIS MC GUIRE at her residence in Paradise Valley. On 6/11/62, a telegram was sent from one of the above rooms to Mr. SANTI CAMPANELLA, JR., Westford Road, Providence, Rhode Island, which read as follows:

"Hi - Am in Las Vegas - Will be home Monday night." signed "Love you, Homespun."

SUBJECT SHOULD BE CONSIDERED ARMED AND DANGEROUS.
