CONTINUED CONTACT WITH [REDACTED] BERWYN CITY COUNCILMAN, HAS DETERMINED THAT [REDACTED] RECENTLY ATTEMPTED TO CONTACT CHUCKIE ENGLISH CLOSE ASSOCIATE OF GIANCANA REGARDING ATTEMPTS ON THE PART OF [REDACTED] TO BECOME A PHONOGRAPH RECORD PUBLISHER IN CHICAGO. IT IS NOTED THAT ENGLISH WITH HIS LORMAR RECORD COMPANY IS IN THIS BUSINESS HERE. VYDRA CONTACTED ENGLISH IN THIS REGARD RECENTLY AND WAS TO MEET WITH ENGLISH AT PEDICONE'S RESTAURANT IN BERWYN, ILLINOIS, HOWEVER, ENGLISH FAILED TO KEEP THE APPOINTMENT. (U)

FOR THIS REASON [REDACTED] CONTACTED ANOTHER ASSOCIATE OF GIANCANA ROCCO INFELICE WHO INFORMED HIM THAT THE PROPER PERSON TO CONTACT IN THIS REGARD WOULD BE "NIGGER JOE" AMATO ANOTHER ASSOCIATE OF GIANCANA WHO ALSO HAPPENS TO BE A CLOSE FRIEND OF [REDACTED]. AMATO IS A CHICAGO HOODLUM WITH RESPONSIBILITY FOR UNDERWORLD AFFAIRS IN NORTH WESTERN SUBURBS OF CHICAGO. HE IS UNDERLING OF GIANCANA IN THIS REGARD. (U)
