We have received information on a very confidential basis to the effect that in May of this year Lieutenant Robert Griffin of the Clark County, Nevada, Sheriff's Office directed a letter to William J. Duffy, Director of the Intelligence Division of the Chicago, Illinois, Police Department, requesting information concerning Chicago hoodlum Samuel M. Giancana. A short letter of acknowledgment was received which was nonspecific and made no reference to Giancana.

According to our source, Giancana had a copy of Griffin's letter within fifteen minutes after it was received by Duffy. As you know, we have previously developed information that Chicago hoodlums have contacts in the police department of that city.
