STATED THAT HE RECEIVED PHONE CALL LAST WEEK FROM AMATO,
FROM PHOENIX, THAT HE AND BATTAGLIA ARE COMING TO CHICAGO
ON DATE INDICATED. PCI GUESSES THAT BATTAGLIA AND AMATO
WILL STAY AT SAHARA WHILE THIS AREA. SAID AMATO WILL
CALL HIM WHEN THEY ARRIVE. PURPOSE OF INFORMANT SEEING
