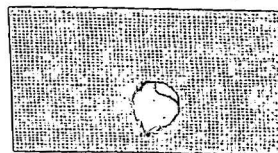
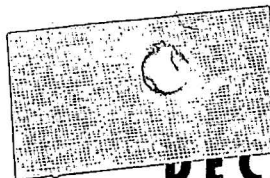

PX 688-C\* ADVISED THAT JOSEPH BONNANO AND WIFE HAVE  
 NOT BEEN AT THEIR RESIDENCE SINCE JULY 31 LAST. PHYSICAL  
 SURVEILLANCE AT JOSEPH BONNANO HOME REFLECTS THAT IT IS  
 NOT OCCUPIED AND THAT WHITE PONTIAC USED BY BONNANO IS  
 MISSING. PREVIOUS INFORMATION FURNISHED BY PX 688-C\*  
 INDICATES THAT JOSEPH BONNANO HAS RENTED A HOUSE IN APTOS,  
 CALIFORNIA AND THAT HE AND WIFE PLAN TO ARRIVE THERE  
 APPROXIMATELY AUGUST 6 NEXT. RECORDS OF AIRLINES, TUCSON,  
 ARIZONA INDICATES JOSEPH BONNANO HAS NOT LEFT TUCSON THIS  
 MODE OF TRANSPORTATION. (U)

FOR INFORMATION SAN FRANCISCO, NEWARK, MIAMI AND  
 PHILADELPHIA, A PCI IN CG OFFICE HAS ADVISED THAT WILLIAM  
 S. BONNANO IS EXPECTED TO ARRIVE CHICAGO APPROXIMATELY  
 AUGUST 7 NEXT, TO MEET WITH PCI AND JOSEPH AMATO. (U)
