MC QUIRE sisters open Desert Inn Hotel for four week engagement starting 9/4/62. No information developed thus far by Las Vegas, which indicates residence for PHYLLIS. (u)

Chicago immediately advise Las Vegas in event information received subject may visit PHYLLIS at Las Vegas. (u)

New York, if feasible, contact JOHN TEETER, for any information as to residence of PHYLLIS and/or CHRISTINE. (u)

Las Vegas taking all possible action to ascertain intended residence for PHYLLIS prior to arrival in order appropriate coverage can be effected. Bureau and interested offices will be kept advised. (u)
