On 5/30/73, BT 545-S advised that MARK LANE and CAROLYN MUGAR, both former members of "THE COVERED WAGON," a GI coffee house, Mountain Home, Idaho, are currently at Wounded Knee, South Dakota, where LANE is acting as legal counsel for AIM Indians.

On 9/10/73, BT 545-S advised that CAROLYN MUGAR has been spending her time at Rapid City, South Dakota, for the past month and a half. MUGAR departed Rapid City for her home in Boston, Massachusetts. She spent the Labor Day holidays in Boston. The exact date she is to return to Rapid City, South Dakota, is unknown. (u)

The same source advised that MARK LANE is currently residing at Rapid City, South Dakota, with CAROLYN MUGAR. She is currently financing LANE's activities at Rapid City in connection with his serving as legal counselor to individuals arrested in the AIM.

For the Bureau's information, all background information, including reports, concerning LANE and MUGAR were furnished to Minneapolis by letter dated 8/30/73. This was done in order to have Minneapolis aware of their background, in view of the case entitled "CAROLYN JANE MUGAR; SA MAURICE E. PEARSON - VICTIM, AFO," Minneapolis file #89-173.

An information copy is routed to Minneapolis, as Subject is residing within that territory.
