MR. BELMONT:

With reference to my conversation with the Director last evening, concerning the ramifications arising out of the Journal-American newspaper article, SAC Simon telephoned from Los Angeles this afternoon and furnished the following information:

Los Angeles has recently developed a new potential criminal informant by the name of [redacted] who claims to be a sister-in-law of the recently deceased motion picture actor Dick Powell. Actually she is a high priced prostitute.

[redacted] has a contact by the name of Kathy Brown, who in turn has dealings with a man by the name of Irving Mink. We have no information as to the identities of either Brown or Mink, and none has as yet been supplied by our new informant. She alleges, however, that in connection with West Coast trips, Irving Mink is responsible for lining up two or three girls. In connection with one trip the informant alleges she was selected as one of the girls, but had to cancel out because she was in the hospital. Three girls are presented on each occasion and one is selected. No money is passed at the time, but subsequently Mink pays the girl chosen \$500. The informant named, as other girls having been involved in the past, Angie Dickerson and Judy McCarthy.

Our informant is maintaining contact with Brown and may be able to secure for us information which will identify Brown and Mink.
