As the Bureau is aware background information concerning the subject was furnished to [the Prefecture of Police, the Renseignements Generaux (general investigative section), Surete Nationale (RGSN), and the Service de Documentation Exterieur et de Contre-Espionnage (SDECE), French foreign intelligence and counterespionage service.] (S) on April 13, 1964 and those agencies were alerted to the Bureau's interest. We have not received any information indicating that subject has come to the attention of our French sources and this case, therefore, is being placed in a closed status subject to being reopened upon receipt of additional information.
