- Q May I have your name and address? A Phyllis Denise Golden, 104-20 Queens Boulevard.
- Q Is that Forest Hills? A Yes.
- Q Now, Mrs. Golden, do you know one Mark Lane? A Yes.
- Q How long have you known him? A Two years and three months.
- Q Where did you meet him for the first time? A In an address?
- Q Yes. A 339 East 77th Street.
- Q And what is that address? A Well, it was his residence.
- Q Now, was the purpose of that meeting for you to discuss a legal problem with Mr. Lane? A Several legal problems.
- Q' Is he a lawyer? A Yes.
- Q Now, after that did you meet him on occasions? A Yes.
- Q And where did you meet him, was it at his office or at your home or where? A At his office, at his home, at my home, at citizen committees and clubs.
- Q Now, during the first period of your acquaintance with Mr. Lane was he engaged in a campaign for Assembly? A Not for the first four months actively.
- Well, eventually he did go into a campaign, is that correct?
- Q And did you assist him during that campaign? A Yes.
- Q In what way? A Everything from floor washer to ceiling painting, sound truck driver, getting brochures prepared.
- Now, during that period of time did Mr. Lane approach you on performing some tests for him? A Yes.
- Q Now, what did he say to you and what did you say to him in discussing the so-called teste? A Well, his explanation for why the tests were - -
- Q Just a minute, let me interrupt you. Did he ask you to make certain tests? A Yes.
- Q Now, tell us what he said to you when he asked you to make certain tests and what the tests would consist of? A He said that this friend of his was running, was conducting a series of tests. It had to do with, as I said yesterday, I am not positive but I am pretty sure it was a lie detector test and they depended on the pulse rate and if I knew how to take a pulse and I said, "Yes,"
- Q Did you consent to perform the tests for him? A Yes.
- At any time did he produce papers to you supposedly from the psychologist for the performance of these tests? A Yes.
- Q And were they in sealed exvelopes? A Yes.
- Q And did he invariably open the sealed envelopes in your presence? A No, I opened the envelope.

- Q Did you follow the instructions that were on the paper?
- For the most part, yes.
- Q Now, will you briefly tell me what these consisted of that you actually witnessed other than the events that happened on January 18th, 1962 which I will question you about later? A Right. Having him walk around naked, whatever you want to call it, for five minutes at a time; having candles put into him anally; inserting pins or needles around the anal area and in the testicles; giving him enemas; putting tooth paste both into the anal opening and the penis; inserting the martini into the penis opening xxx with and without alcohol; stirrer/shaving pubic hair, tweezing it; taking a temperature; picutres, obscene pictures, taking and showing of obscene pictures of himself; playing a tape recorder supposedly not known to him and then playing it back to him; having him masterbate. He wanted me to beat him, that was not done and having someone else present prior to the 18th, was not done.
- Q Male or female? A Female.
- Now, these tests I take it were conducted from time to time between and by you and Mark Lane, is that correct? A Yes.
- Q How often would you say during the period of time of your acauaintanceship with him and up to January 18th, XAGX 1962, were these tests done? A Approximately twelve times.
- Q Where were they conducted? A Either at his apartment - -
- Q Address please. A 339 East 77th Street, his former apartment my apartment, 104-20 Queens Boulevard. The first couple of times in Albany. It was in a hotel at the corner of State Street and Broadway and then after that at the Wellington and then at the DeWitt Clinton.
- Q Were any conducted in his office? A No.
- Quring all this period of time up to January 18th, 1962, were you of the opinion that these tests were legitimate, scientific tests? A. For part of the time, yes.
- Q In the beginning? A Yes.
- Did there come a time when you knew that they were phony?
- Q How did you know that they were phony? A First of all I started thinking about it a little and I realized, I put two and two together and stopped making excused and also I saw him typing up a set of tests in his office.
- Now, on January 18th, 1962, did you receive a call from a girl friend of yours by the name of Lee Stephenson? A I know her as Lee Stevens, yes.
- Q Did Lee say she was coming out to your apartment in Forest Hills? A She had said that she had a business appointment for lunch out here in Queens and that when she was through and on her way back into the city she would stop off and say hello.
- Q After this did you get a call from Mark Lane that he was coming out also? A Yes.
- Q Who arrived first, Lee or Mark? A Lee.
- Q Did you tell her that Mark was coming? A Yes.
- Q Did you also brief her on the so-called tests that had been previously conducted? A She knew about them.prior.km January 18th was not the first that she knew about them?

- Q She knew about them? A Yes.
- Q Did you tell her that Mark might possibly ask her to participate?
- Q Did Lee consent to so participate? A Before her arrival when we were discussing it her answer was, "Well, we will see what happens."
- Well, WEFEXAKMAXINY when Mark came in did he request both of you to conduct the tests? A Yes. Wait a second, he did not request both of us to do it. He gave me the test and as I knew them actually I was the person who asked Lee to do it. He was not actually the person who asked Lee.
- Q. I show you a sheet of paper and ask you if you ever saw that before? A Yes.
- Q What is it? A That was the test that Mark handed to me in a sealed envelope on January 18th, 1962.
- Q At your apartment? A Right.
- Q are you familiar with Mark Lane's handwriting and printing? A Yes.
- Q I ask you in whose handwriting or printing this is? A In Mr. Lane's printing.
- Q Will you put your initials on the reverse side, please? A WITNESS PLACES INITIALS P.G. ON REVERSE SIDE.
- Q Now, tell us what tests, so-called tests were conducted in your apartment on January 18th, 1962 in complete detail and just what you did and what Lee did and what Mark did? A The first thing was Mr. Lane had his temperature taken. First he undressed himself as far as the shorts were concerned and then he laid face down on the bed and I said, "You have to remove your jockey shorts, too," and he slid them mff down and in that I assisted him. After that I inserted a candle into Mark anally. After that I tweezed some pubic hair. And then Lee then beat Mark with his own belt on the buttocks. Then pins were inserted around the anal xxxx area and into the testicles. Then he got an enema. Both of us area and into the testicles. Then he got an enema. Both of us gave him the enema. I believe held the bag and I put it in and then he started to masterbate after the enema was completely in him and he wasn't supposed to relieve himself until after he maker mesterbated, but he claimed that he had to relieve himself, so he did, and then when Mark came back into the room the next thing on the instruction sheet was for him to masterbate himself and at which point he got, Mark got embarrassed and he decided, he couldn't do it and a comment was made by either Miss Stephens or myself that the tests can't continue unless he does it, etc., And then Miss Stephens, because he still said he couldn't etc. do it, and then he said, "Do something else," and then he would do it later. So then Lee then inserted a candle into his anus and then I believe she beat him again, I am not positive, and then Lee having read the instructions sheet along with me, suggested the obscene pictures. Before the pictures, the first set of pins xmm or needles, whatever you want to call them, were just regular according to the instruction sheet. Mark was also supposed to have inserted into himself red hot needles, so Lee lit the needles and I put them in and we both did it.
- Q When you say you inserted the needles where did you insert these needles? A The same place as before, the testicles and around the anal opening. Then at that point, to the best of my knowledge, I believe was when the next instruction was to be for Mr. Lane to masterbate which he still hadn't done and he kept on saying, "You know I can't do it, you know, I am too embarrassed,"

or something like that and Lae asked him if it would be easier if she did it and with that she proceeded to masterbate him.

- Q Did he reach a climax? A Yes, he did. It was at that point that Lee suggested taking the picutre and I got the camera. One of the pictures showed Mark lying face down on the bed with a candle inserted rectally. Another was taken of Lee beating him. Another was taken of Mr. Lane on his stomach, not only with the candle inserted rectally, but also with two stems of artificial flowers. A fourth was taken of Mr. Lane together with Lee xinging singeing the hair on his testicles with a lighted match. I do not accurately recollect the other two pictures that were taken, but they were of a similar nature. After a few of the pictures had been taken, but not all of them, his hands were tied behind his back, Mark's hands were tied behind his back. At that point I believe that Mr. Lane was given another enema by Miss Stephens and at that point it was 6:00 o'clock. When I left the room. After that I did not see what took place in the room. At one point I heard from another room what to me stemmed sounded like someone being beaten with a belt. Whether it actually took place or not I don't know. I wasn't there and there was a lot of no noise at all, so, as I said, I don't know what went on.
- Q Eventually did you go into the room where Mark and Lee were?
- Q Did you come up to the close proximity of the room? A Yes.
- Q And did you see Lee at that point? A Yes.
- Q was she dressed or undressed? A She was wearing a two piece suit. She still had her jacket on and her skirt on but her skirt was pulled up to her waist and under that she was nude.
- Q Now, what was the condition of Mark Lane at that point? A I wouldn't know, I didn't see him.
- Q After that did you have a conversation with Lee as to what happened while you were out of that room? A Yes.
- Q What did Lee tell you happened? XXXXXXXXXXXXXXXX A She told me that after I left that she and Mark were looking at the pictures that had been taken and that she inserted the martini stirrer into him with the alcohol on it, that she had beaten him again and that Mr. Lane made advances toward her and that because she had been aroused by what happened she told me that she had intercourse with him.
- Now, during this incident that you had just described, the whole incident, did you take pictures? A Yes.
- Q I show you a photograph and ask you if that is one of the pictures that you took? A Yes.
- Q Whose picture is that? A Mark Lane's.
- Q And is there another person's hand in the picture? A Yes.
- Q Who is that? A Lee Stephens.
- Q. Would you kindly put your initials on the reverse side of that? A WITNESS PLACES INITIALS ON REVERSE SIDE OF PICTURE.

- Q. May I have your name and address? A. Elizabeth Lee Stephenson, ll Fifth Avenue, New York.
- Q. How old are you Lee? A. 24.
- Q. Married or single? A. Single.
- Q. Are you employed? A. Yes.
- Q. By whom? A. Pacific Enterprises.
- Q. Where is that located? A. Los Angeles.
- Q. Why are you in New York? A. I'm their New York representa-
- Q. Where is the New York Office? A. It's an advertising speciality company. They don't need an office. I'm their office.
- Q. Do you operate from your home? A. I use my home phone and I have closets and drawers in which I store samples and papers. That's all I need.
- Q. Then you do operate from home? A. Yes.
- Q. Do you know Phyllis Golden? A. Yes.
- Q. How long have you known her? A. Since August or September.
- Q. Do you know where Phyllis lives? A. Yes.
- Q. What is the address? A. 104-20 Queens Boulevard.
- Q. Is that the Parker Towers? A. Yes.
- Q. On January 18, 1962 did you have occasion to visit Phyllis at the Parker Towers? A. Yes.
- Q. What time of the day did you arrive there? A. About 2:30, three o'clock.
- Q. Some time later did a man come to the apartment? A. Yes.
- Q. Do you know the name of that man? A. Mark Lane.
- Q. Now, after he arrived at the apartment did he request you or Phyllis, or both of you, to do something to him? A. He asked Phyllis to ask me if I wanted to be a witness to one of his tests.
- Q. What kind of tests did he say these were? A. These were, as far as I knew, tests some psychiatrist was running, with taking the pulse for the electric chair. I don't know what it was about.
- Q. Did you consent to be a witness? A. I didn't know what to do and finally I figured it would be a good idea if I was a witness.
- Q. Suppose you tell us about what time of that day did that begin? A. Possibly around 3:30, four o'clock.

- Q. How soon after Mark had arrived did he start? A. Half hour.
- Q. Tell us just what happened, what he did to you, what you did to him, what he did to Phyllis and what Phyllis did to him?

  A. He undressed and Phyllis started out by sticking a candle in his rectum.
- Q. Now, let me interrupt you before you go any further. Had he given Phyllis instructions as to what to do? A. He had given Phyllis a list of instructions that she had given to me to look over, that he wanted her to give me.
- Q. Did you see Mark hand these instructions to Phyllis?
- Q. Did she show you these instructions before he came in?
  A. No, I didn't see them. She told me they were in his own writing.
- Q. Did Phyllis show you the instruction sheet? A. Yes.
- Q. I show you this piece of paper and ask you what that is?
  A. That is the instructions Mark gave Phyllis, as far as I know.
- Q. Would you put your initials on the reverse side of that piece of paper? A. WITNESS PLACES HER INITIALS E. L. S. ON THE REVERSE SIDE OF THE SHEET OF PAPER.
- A. Mark took off his Q. Start again, tell me what happened? A. Mark took off his clothes. At first Phyllis, I think the first thing she did, she put one candle with a big end in his rectum and then another candle with a smell end in his rectum with vaseline and pushed them all the way up so that about a foot of candle was in his rectum. Then she plucked hair from his testicles with tweezers, and she put a cocktail stirrer in the hole of his penis and then put alcohol on the cocktail stirrer and put it in his penis and then put alcohol on his penis. And she gave him an enema and made him hold the enema in him while he masturbated. He couldn't hold it any longer and had to go and relieve himself. We beat him with a belt that raised welts on his buttocks. We took humiliating pictures of him. We hid one of the pictures that had his face in it so we would have it as evidence for something if we ever needed it. And we repeated the same bit with the candle, with the enema, with the cocktail stirrer, with the tweezers and with hit needles. We got them hot over a cigarette lighter and poking them in his testicles and his rectum and beating him with the belt. And he wanted us to do it more and more. He didn't want to stop. Pretty soon it got late and Phyllis had to feed her daughter and she left the room and I started doing these things, beating him, with the cocktail stirrer, with the alcohol, and then instead of masturbating he wanted me to masturbate him. Phyllis and I wanted him out of there, wanted to get him home, so I thought maybe if he came he would go home. I tried and the nex I tried and the next thing I knew he was trying to take my clothes off me. He wanted to make love to me. He got my clothes half off of me. I was just trying nicely to push him away and he had most of my clothes off me. Finally I said to hell with it, I'll take them off. And Phyllis like came to the door and he told me to tell her not to come in for a while. So I told her not to come in for a while. He made love to me.

- Q. Let me interrupt you. The word making love to me doesn't mean anything to me. I want to know what you mean by that expression making love to me? Tell us just what he did?

  A. He inserted his penis in my vagina.
- Q. Continue? A. He was trying to do it very saddisticly.
- Q. That does not mean anything to me. I want you to tell me exactly what you mean by the word saddisticly? A. He was trying to force it in very hard to hurt me and I wouldn't let him. He tried to put my legs up in the air so it would hurt me more and I wouldn't let him. Finally he stopped. I don't know whether he reached a climax or not. I think he did. I'm not positive. The reason I'm not positive is because afterwards he kept trying to keep getting near me and trying to do it again and I wouldn't let him. That's why I think I'm not sure whether he did or not because he kept trying to do it again and I wouldn't let him. I got dressed and I, in so many words, told him that I was very ashamed with what happened. I never wanted to see him again. I told him I didn't want anything like this to happen again.
- Q. Alright now, let me ask you a few questions. When you were giving Mark Lane this so called test were either you or Phyllis nude? A. No. I was completely dressed in a suit and Phyllis had a housecoat on.
- Q. Did you show Mark any nude pictures? A. We showed him the humiliating picture of himself that we had taken.
- Q. Other than that? A. No.
- Q. During the course of this test I take it you did take some pictures? A. Yes. Phyllis has a vase with long stem flowers in it and we stuck them in his rectum and we took pictures of that And also during the test he wanted us to use our imagination for things, so I used my imagination.
- Q. In what way? A. I took matches and set fire to the hair around his rectum and testicles.
- Q. Did both you and Phyllis take pictures? A. Yes.
- Q. What kind of camera does Phyllis have? A. Polaroid.
- Q. I show you this photograph and ask you if you ever saw it before? A. This is the one picture that I know of for sure that we got with his face in it.
- Q. Who took that picture? A. Phyllis.
- Q. I direct your attention to a hand in the lower part of the picture and I ask you whose hand that is? A. It must be my hand.
- Q. And what are you doing at the time? A. I imagine I'm sticking needles in his testicles. Hot needles.
- Q. Would you put your initials on the reverse side of that photograph? A. WITNESS PLACES HER INITIALS E. L. S. ON THE REVERSE SIDE OF THE PHOTOGRAPH.

- Q. Now, after Phyllis went into the baby's room to give the baby her bottle . . ? A. She took the baby into the kitchen to cook supper for her.
- Q. You were left alone with Mark, is that correct? A. Yes.
- Q. And I understand that eventually you became nude too? A. Yes.
- Q. You toldme before he had sexual relations with you, is that correct? A. Yes.
- Q. Did he have sexual relations with you in an unnatural manner, or attempt to have relations in an unnatural manner, and if so, how? A. He had relations with me in a somewhat natural manner to the extent that he did it naturally but tried very much to hurt me at the same time. Previously he tried to hurt me and attempted to insert it in my rectum, which is unnatural.
- Q. Did he succeed? A. No, I refused to let him.
- Q. Did he place his penis in the proximity of your rectum?
- Q. Did he request you to have unnatural relations in any other manner? A. Yes.
- Q. How? What did he say to you and what did you say to him and what did he do? A. He requested me to place my mouth on his penis and I told him he was out of his mind.
- Q. In the instructions that he gave you and Phyllis, did he request you to use the belt on him? A. Yes.
- Q. Did you or Phyllis do so? A. Yes.
- Q. Where did you get the belt from? A. His belt. From his pants.
- Q. And how did you or Phyllis use it? A. Beating on his buttocks with it.
- Q. Who did that? A. I did.
- Q. At anytime during this orgy, did you or Phyllis tie his hands? A. Phyllis tied his hands.
- Q. Where? A. Behind his back, right after the beginning of it at his request.
- Q. And were his hands tied to any fixed position? A. Just behind his back and not too securely.
- Q. And was that pursuant to his instructions also? A. Yes.
