The Washington Field Office has advised that subject was arrested in the vicinity of the Supreme Court Building in Washington, D. C., while demonstrating on 4/21/71. He furnished his address as Wolf Swamp, Bethel, Connecticut.

Subject is a well-known New York attorney who has been involved in radical and anti-Government activities for a number of years. Within the last year he has been active in antiwar activities and has been associated with the actress, Jane Fonda, in this connection. He has also been living in a common-law relationship with Carolyn Jane Mugar, a wealthy Boston woman, who apparently has been assisting him financially. He is described as a white male, forty-five years old, six feet, 180 pounds, brown hair and brown eyes. His permanent address has been unknown for some time.

New Haven immediately conduct discreet inquiry to determine subject's residence and current activities. Promptly advise the Bureau, New Orleans, and New York as extensive investigation is being conducted regarding his location and activities.

audiences both in the U.S. and abroad in an attempt to convince his audiences that Oswald was, if not innocent of the Kennedy murder, at least a part of a conspiracy. He alleged that the Bureau and other Government agencies conspired to cover up the true facts concerning the assassination. More recently, he has associated with Huey Newton of the BPP and various leaders of the New Left. Within the last year he has been closely associated with Jane Fonda and has, along with her, been a leading antiwar activist. [The most recent information received concerning him indicated that he was in Paris, France, in 3/71, where he made a number of contacts with Vietnamese, revolutionary organizations, and individuals of the Far Left including Alan Krivine, leader of the Communist League and with a member of the Fourth International European Trotskyists organization.] He travels widely and his residence has been unknown for sometime. In order to establish a logical office of origin in this case and to thereafter consider him for inclusion on the SI, it is desirable that his permanent residence be established.
