On 10/17/60, source advised that JOAQUIN SANCHEZ contacted the rental office of the Terrace View Apartments concerning an apartment to be rented in that building by JOSE VAZQUEZ. He was advised that the telephone number of this renting office is HAvemeyer 4-2312.

On 10/17/60, source advised that JOSE VAZQUEZ, Consular Attache, Cuban Consulate, NYC, contacted MARGARITA MENESES, and stated that the "Commandante" would be coming from Washington that day and wanted to know if they could stay at MARGARITA's apartment. According to the source, VAZQUEZ later told MENESES that Commandante SILVA is in NYC and would be staying at her apartment. It will be noted that MENESES' apartment telephone number is TA 5-5571.

On 10/18/60, the source advised that JOSE SANCHEZ, head of the July 26 Movement in NY, contacted JUNE COBB, and invited her to VAZQUEZ' apartment later that evening. He said it would be an informal party, and that she should come to 310 East 49th St., apartment 10-F. COBB advised SANCHEZ that her room number was 1510, and her telephone number is PLaza 3-5900.
