desired to leave the impression that he was cooperating but in fact he was not. His answers were evasive, indefinite and uninformative. It was believed that his attorney had instructed him to respond in this manner and it was felt that he may have been urged by ANGEL BOAN and his attorney to agree to interview without counsel for the purpose of ascertaining the direction and depth of the FBI investigation rather than chance having the FBI dispense with the interview completely if he insisted on counsel.
