NOTE FOR SACS, SAN JUAN AND MIAMI:

CIA, Washington, D.C., on 10/22/64 advised that activities in 10/13/64 San Juan LHM have no connection with CIA operations. CIA request, following sentence has been added to 10/13/64 LHM: Representative of CIA, Washington, D.C., on October 22, 1964, advised that the activities in Puerto Rico, described above, have no connection with CIA operations. Add this sentence to your copies of LHM and San Juan advise ONI, INTC, OSI and INS, which received copies. San Juan also furnish copies of 10/13 and 10/16/64 LHM to Customs, Coast Guard and CIA locally and furnish copy of each airtel and enclosure to New York in view of indication Cubans in New York are being recruited. No comment should be made to POPR indicating whether activities described in 10/13/64 LHM are or are not a CIA operation.
