Bank account of ELIZABETH H. BARAD, head of the membership committee of captioned organization, was reviewed, but no significant deposits or withdrawals were found.

On 5/19/60, Mr. JAMES HILDABRAND, Security Manager for the Columbia Broadcasting System (CBS), advised that in viewing the photographs of ROBERT TABER, furnished by Bureau in the referenced airtel, 5/18/60, he believes the person depicted to be definitely identical with the CBS employee ROBERT BRUCE TABER. NYO Agents are attempting to discreetly observe TABER to make positive identification.

A check of banks in an attempt to locate accounts of Cuban Permanent Mission to UN employees, not previously located, has determined that CARLOS BLANCO, Alternate Representative to UN, maintains an account with the UN branch

It will be noted that [WF 1196-S*] ^(S) has furnished information which indicates that one MARJORY DE RIOS is furnishing information to TABER which is probably to be used in subsequent issues of "Fair Play" similar to that furnished to the Bureau with NY airtel, 5/5/60. The possibility exists that an obligation to register may be incurred by TABER or the Committee through his connection with RIOS ~~(S)~~

It will be noted that JON SPELLER of NYC, who recently returned from Cuba, advised that JUNE COBB, an employee of the Cuban Government in the office of FIDEL CASTRO, identified MARJORY RIOS as the assistant to TONY DE LA OSA, Chief of Public Relations in the Cuban Ministry of Foreign Affairs. SPELLER advised that according to COBB, RIOS and DE LA OSA "handle the Fair Play For Cuba Committee" ~~(S)~~ (u)

New York is preparing a report on all investigation in this matter to date. This report will be submitted to the Bureau immediately.
