[5] NK (2227]s was mentioned by FILIBERTO ROJAS, the Coordinator at Hoboken, as one of five individuals as a potential leader at Hoboken when ROJAS left the United States on 9/28/61 for Cuba. Although this informant was not selected, he continues to be highly regarded by the membership. However, on 11/8/61, this informant advised that he feels that now would not be an advantageous time to try to advance to a leadership position. He stated that the leadership is extremely jittery and that if they feel rightly or wrongly that various leaders might be in danger of imminent arrest, they would be ordered back to Cuba. It is noted that the new Coordinator at Hoboken has been reported to have fled the United States.
