She asked him if it was possible to send something on the OSWALD press conference for our Soviet correspondents. No one it seems has sent any telegrams. Strel said he will give them something. He only understands something he sees. OK Then Mr. Satukov in Moscow got on. Strelnikov asked him what press conference or meeting he was talking about? The meeting. Oh, I was there, "radio" was there, Trud was there, Tass was there. I understand. Now Strel is beginning to transfer his notes, and will send for a stenographer. I just finished the end of the notes. Sat understands. What did you see? Strel said much. ok. Then Strel mentioned that last nite in a NY hall Mrs. Margarita Oswald's attorney, Mark Lane, stated that in the FBI report to the Warren Commission there was certain information which Lane is following and which will show that her son did not kill the President. One of these things is that 2 shots shots were heard in the presidential cortege. Then Strel said not 2 but more than 3 shots were heard. Three shots were reported by the police. The rest of the conversation was about the number of shots and the direction they came from.</p>

The NATO forces want to go into Cyprus. The Cyprus delegation is not satisfied with a guarantee of the sovereignty of the country but want to prevent Turkey from taking part of the country. Undersecretary of State Ball was in NY and may have a new plan. Then Dean of Great Britain spoke and urged the parties to have restraint Kuz then said that Ball's plan was the one rejected by the Cypriot government.</p>
