ReBulet dated 8/3/61 instructing that WFO await results of Baltimore's interviews and thereafter prepare a memorandum containing pertinent details re the subject. In the absence of data showing subject is currently engaged in activities within the jurisdiction of the FBI, WFO should place this matter in a closed status.

Enclosed herewith for the Bureau are nine (9) copies of a letterhead memorandum together with a memorandum of evaluation dated and captioned as above. The informants mentioned in the letterhead memorandum are as follows:

WF T-2 is WILFRED MC LARIN (protect by request)  
WF T-3 is [WF 1133-S\*] (s)  
WF T-4 is [WF 4134-S\*] (s)  
WF T-5 is FELIPE MARTINEZ RIVERO (protect by request)  
WF T-6 is [WF 1196-S\*] (s)

YVONNE JONES, referred to in the enclosed letterhead memorandum was the subject of the case captioned "YVONNE JONES, Pan American Health Organization, WDC, LEUN," (WFO file 138-4125; BA file 138-1839).

Inasmuch as the subject is no longer in the U.S. this case is being closed.

The enclosed letterhead memorandum is classified "Secret" due to the sensitive nature of [WF 1196-S\*]. In the event this information is later downgraded, it should receive the classification of "Confidential" inasmuch as it reflects investigative interest in a diplomatic establishment of a foreign power and because the information reported could reasonably result in the identification of informants of continuing value and compromise the future effectiveness thereof.
