The title of this case is being marked "CHANGED" to reflect the subject's complete name as contained in the records of the United States Department of State.

Enclosed herewith for the Bureau are nine copies of a LHM together with a memo of evaluation dated and captioned as above.

The first informant mentioned is FELIPE MARTINEZ RIVERO, former Clerk, Cuban Military and Air Attaches Office, Embassy of Cuba, WDC, (protected by request), who defected from the Cuban Government on 11/29/60, and elected to remain in the U. S. He furnished the info to SA JOHN G. GOEDTEL (XU)

The second informant is (WF 290-S*) (S)

YVONNE JONES, referred to in the enclosed LHM was the subject of the case captioned "YVONNE JONES, Pan American Health Organization, WDC, Loyalty of Employees of the United Nations" (WFO file 138-4125).

WFO will check Central Office, INS, WDC, concerning subject and subject's father to determine the type of U. S. visa possessed by them and thereafter submit recommendations concerning interviews with the subject and his father.

The enclosed LHM is classified "Secret" since the info received by the USDS from the American Embassy, Karachi, Pakistan, dated 12/29/61, was so classified. In the event of downgrading the LHM should receive the classification of "Confidential" inasmuch as it reflects our investigative interest in a diplomatic establishment of a foreign power and because the info reported could reasonably result in the identification of an informant of continuing value and compromise the future effectiveness thereof.
