Therefore, no report is being submitted at this time; however, investigation is continuing in an effort to determine specifically whether captioned organization is active or has adherents in this territory making efforts to establish units.

There follows the results of investigation conducted throughout the Resident Agency territories as to the existence of captioned organization.
